Minister Policies

Marriage is a part of God's plan for humanity. In the Garden of Eden, He instituted the sacredness of marriage. God gave the first bride away and performed the first ceremony. Because it is a holy establishment, we do not take it lightly. The following provides important information about utilizing church facilities and our ministers. Please read it carefully.

Things you should know:

- 1. The minister will review an Engagement Covenant that will need to be signed by both the bride and the groom at the time of the first consultation.
- 2. All couples will be required to complete premarital counseling. It is not necessary that our ministers provide the counseling.

Counseling:

- Our counseling program typically requires six sessions with the couple together.
- If counseling is not provided by one of our ministers, it will need to be approved.
- If counseling is not provided by one of our ministers, two sessions will need to take place with the minister performing the wedding (1) reviewing and signing the Engagement Covenant and (2) ceremony planning

Honorarium

The typical honorarium for our ministers is \$150.00 This can be given directly to the minister.

The building will be cleaned by our maintenance personnel after the wedding is over. We ask that you remove all your equipment as soon as the wedding is over. All Saturday weddings require the building to be completely vacated by 8pm.
You will have access and use of the building the day of the rehearsal and the ceremony.
ADDITIONAL FEES:
If you wish to rent a room for the rehearsal dinner the cost will be \$100.00 (This is for building use and additional set-up)
If you require sound for the reception the cost will be \$100.00 and is restricted to certain areas of the building.
If you wish to use the screens in the worship center, the cost will be \$100 for an additional A/V Tech.
If you wish to rent tablecloths, the cost will be \$10 per tablecloth used.

Amendment to the Constitution and By-laws of Trinity Baptist Church

Statement on Marriage and Sexuality

We believe the term "marriage" has only one meaning and that it is marriage sanctioned by God, which joins one man and one woman in a single, exclusive union, as, delineated in Scripture.

We believe that God intends sexual intimacy to only occur between a man and a woman who are married to each other. We believe that God has commanded that no intimate sexual activity be engaged in outside of a marriage between a man and a woman.

We believe that any form of sexual immorality, such as adultery, fornication, homosexuality, bisexual conduct, bestiality, incest, pornography or any attempt to change one's sex, or disagreement with one's biological sex, is sinful and is contrary to God's Word.

We believe that in order to preserve the function and integrity of the church as the local Body of Christ, and to provide a biblical role model to the church members and the community, it is imperative that all persons employed by the church in any capacity, or who serve as volunteers, should abide by and agree to this Statement on Marriage and Sexuality and conduct themselves accordingly.

We believe that God offers redemption and restoration to all who confess and forsake their sin, seeking His mercy and forgiveness through Jesus Christ.

We believe that every person must be afforded compassion, love, kindness, respect, and dignity. Hateful and harassing behavior or attitudes directed toward any individual are to be repudiated and are not in accord with scripture nor the doctrines of the church.
